2021 Conference and Weed Forum Cancelled

The 2021 NDWCA Conference and ND Ag Commissioners Weed Forum originally scheduled for January 12-14, 2021 has been cancelled, due to rising Covid cases and restrictions.

With the current restrictions that have been set by the Governor and Burleigh County, it is virtually impossible to have a safe convention for all to attend. With the current guidelines, socially distancing at the conference would be virtually impossible, with or without masks. Getting speakers to attend was another issue. The number one issue, is the safety of our members. Most of our members are close to if not already in the vulnerable age group. The board does not want to lose any members because they contracted Covid at our conference.

This decision did not come easy. There was a lot of discussion at the June board meeting, and the board decided to keep on track. At the September meeting, it was a very intense meeting. Each board member tried to find a solution to keep on track. At that time, the decision was to cancel the area meetings, but keep moving forward with the conference. The planning committee was supposed to meet via conference call last week to continue to plan the convention, final preparations, etc.. But it was decided to have the entire board be on that call. After some discussion, everyone felt that it was time to pull the plug, so to speak, on this upcoming convention. Nobody could find a solution. So by roll call vote, a unanimous decision was reached. We will discuss the possibility of adding topics to the May sprayer schools to further the education missed by the convention.

Discussed doing a small virtual convention, but since a lot of members do not have the technology to do so, and not wanting to exclude some of the membership, NO virtual conference will be held.

The annual meeting was discussed. The decision was to do a kind of like hybrid approach. The annual meeting minutes are posted on our website at www.ndweeds.com. The annual budget is also posted on the website. We want to encourage our members to go on the site and review them.

In 2021, we need to vote for industry representative to the board of directors. Bill Walker has been that representative for a number of years. He has graciously accepted the nomination again.

2nd vice president of the association needs to be filled, because as all of you know, according to our by laws, 2nd vice president, currently Jim Hennessy moves up to 1st vice president, 1st vice president, currently Travis Jepson becomes president, while the current president, Cody Schnabel becomes an advisor to the board for 1 year. Our current past president, Jamen Windish goes off the board.

Areas I, II, & IV are eligible areas for someone for 2nd vice president. Nominated for 2021 are Stan Wolf, Cass County, Area II, and Dylan Ripplinger, Burleigh County, from Area IV. The bios for both of these nominees are on the next page.

The first week of December, full members will receive a cover letter and a post card ballot in the mail. The ballot will have the return address, and will be postage paid. Just fill it out, and throw it back in the mail. This letter/ballot will be going out to the contacts we have on file for our members.

You will vote yes or no for approving the minutes and the budget, separate votes.

You will also vote for Industry representative. Bill Walkers name will appear on the ballot. There will also be a blank space on the ballot for a write in name if you so desire. Vote for one name only.

You will also vote for 2nd vice president. Both Stan Wolf and Dylan Ripplinger's names will appear on the ballot. There will also be a blank space for a write in name if you desire, but remember only from Areas I, II, & IV. Again, vote for one name only.

At the bottom of the ballot, please fill in the name of the member voting, for instance name of county/city/etc.. The next line will be for the signature of the person who voted. If you recall, we do that in a way at our in person meeting as well.

If you receive the ballot, and you are not the voting representative, please get in touch with that person, and get it to them to vote.

If you did not receive a ballot by December 9th, e mail Merlin at ndwca@westriv.com. It may be that someone else received it and have not contacted you. If we have a doubt of who to mail the ballot to, we will contact someone to find out.

Please mail back the ballots as soon as possible. We would like them before December 31st. Merlin will take the ballots to the board meeting on January 12 to be counted and a winner announced. We will announce the winner on our website, and also put it out on list serve. The board wants to thank you for your patience through this pandemic.
