Industry Report

Again, I'll start by saying there has not been much change from our last industry report, some products continue to be tight and short supply, pricing on some products have at least stabled off for now, we expect to see a new round of price increases this fall when manufacturers start to announce their programs for 2023, some have already said to expect increases.

*****In 2022 we did see unprecedented price increases from 20% on the low to as much as 160% or more on the high, glyphosates and 2,4-D products did take the highest jumps, but many products were in the 20% to 40% ranges overall, while we hope to not see these again in 2023, we still will see some increases as rumored by the manufacturers.**

*****CORTEVA** CORTEVA has announced that we will across the board price increases from 3% to 8% on all of their products. **Mike Otto** – is the new Territory Manager for CORTEVA in Western North Dakota, his phone number is – 1-210-517-7491, I do not have his email contacts yet, he will be covering the areas in North Dakota that Clair covered.

*****Bayer** – As a reminder – has sold its specialty division to CINVIN (Investment firm in London) as previously reported, Their new name will be **Envu** – meaning “environment and vision”, this is to take effect sometime in October 2022

Glyphosate products, 2,4-D products and others are still in short supply and supply is not expected to catch up until sometime in 2023 now.

Surfactant costs have risen across the year as well, they have taken between 15% and up as much as 30% on some products, the oil base or petroleum-based products have taken the highest increases.

Education Committee Report

We held a very successful three-day symposium at the 4H camp in Washburn, ND. We had speakers giving us updates on the use of chemicals and biological agents for the control of noxious weeds, we had live weed identification training on how to identify noxious and invasive weeds. Along with these trainings we were also given live demonstrations on the use of spraying drones and how they can be incorporated into our noxious weed control programs. We are working on developing trainings during the off season (winter) for weed board members, county commissioners and weed officers along with a new weed officer training manual for new weed officers. We will continue to hold our regular sprayer schools in the spring, and may also continue the multiday educational leadership training to be held in the late summer.

We are also having educational booths at many different other associations' annual meetings and Agriculture Shows across the state. This will give benefit to these attendees by informing them with educational and informational material about the identity of the noxious and invasive weeds that we are trying to control and why we are trying to control them.

We have started sending out to all the schools across the state the poster contest rules and information. This contest is open to all 5th and 6th grade students across the state who can create a poster about the trouble noxious and invasive weeds can cause. You can judge these posters at our annual meeting in January.

NDDA Report by Richard Weisz, NDDA Noxious Weed Specialist

LAP and TAG Update: LAP allocations for the new 2022-2023 fiscal year have been sent out. There are eligible counties who have not turned in their LAP NOGA's to accept their new 2022-2023 allocations. Please sign and send back to me when you are able if you have not done so. TAG funding remains the same at \$5,000/county and \$2,000/city over the biennium. Reallocation for TAG will not be taking place this biennium.

USFS Funding:

If anyone has proposals they would like to submit, please let me know.

County Weed Board Visits:

Still ongoing and we've visited about half the state counties so far. These visits will always be ongoing. They help me understand the dynamics between counties and how each other operate.

Palmer Amaranth:

Palmer amaranth has been found in three counties this year so far. Those counties are Hettinger, Kidder and Traill. Each situation had small infestations where palmer is no longer detected.

Invasive and Troublesome Weed Guidebooks/Pocket guides:

Both books and pocket guides are available for the Invasive and Troublesome Weeds in ND. If you would like more, please let myself know.

Law Books:

The North Dakota Noxious Weed Law & Regulations law book have been updated and are available. If you are interested and want some, please contact me.
