NDSU UPDATE

Smith to Lead the NDSU Extension Pesticide Program



Hi, my name is Madeleine Smith and I have spent the last 15 years working in Agricultural Research and Extension. Originally hailing from Nottinghamshire in the UK, I completed my BSc. in Plant Science, Masters in Plant Breeding and Biotechnology and a PhD in Plant and Environmental Science specializing in Plant Pathology in the UK; before heading stateside to work at Texas AgriLife at Texas A & M at Amarillo. In Texas, I spent three years working with viral diseases in sugar beets. While in Texas I was exposed to Extension and realized what a great system this was for helping translate important research information to Farmers and Ranchers in a practical way to help them be efficient and productive. When the opportunity came to work at the University of Minnesota as an Extension Specialist in Small Grains and Canola Pathology, I was thrilled to take up the opportunity. I spent seven years at the University of Minnesota working on the management of diseases such as Fusarium Head blight including evaluating fungicide treatments and biological control methods. My passion for Extension and working with the farming and ranching community led me to make the transition to work-

ing with NDSU as an Extension Agriculture and Natural Resource Agent for Pembina County for almost 5 years. Here I enjoyed close working relationships with the farmers and ranchers in my county as well as helping administer the private pesticide applicator recertification training to our applicators. I learned how critical the pesticide applicator training and certification program is to those who are involved in this type of work for learning about safety and regulatory issues and so I am delighted to be taking up the reins as the new Extension Pesticide Specialist and building on the program that Andrew Thostenson has developed and run so effectively for nearly 30 years. I look forward to working with all of you to fulfil your training needs and keep the program evolving as we respond to the changing times ahead.



Noxious Weeds Update from North Dakota Department of Agriculture

Please note that the Notice of Grant Awards for the Targeted Assistance Grant (TAG) is set to expire on December 31, 2024; however please let us know by <u>December 15th</u> if you need an extension as the funds are available until the end of the biennium, June 30, 2025.

A reminder that **all Landowner Assistance Program (LAP) funds expire on December 31, 2024**. Please submit all receipts for expenditures by January 31st. Once all vouchers have been processed, we will determine the available amount for reallocation for the remainder of the biennium ending June 30, 2025.

This is a reminder that if you applied, signed, and received the Mapping and Technology Grant, you are required to send NDDA data for THREE years. We haven't received most of the data necessary at this point; it is due on or before March 1st each year for the next three years.

We also would encourage all counties to send in any mapping data possible as we'd like to collect and collate it into a state-sized map showing infected areas; this helps show the need for our continued state funding.
